## METRO NASHVILLE CARES FUND

In 2020, the office of Mayor John Cooper allocated \$10 million of CARES Act funding to help Davidson County residents in need of assistance with rent, mortgage or utility payments as a result of the COVID-19 pandemic. Side-by-side with the Mayor's Office, United Way and the CARES Committee allocated these dollars into Nashville quickly by funding nonprofit partners and service providers working with those disproportionately impacted by COVID-19.

### Dollars allocated: \$9,850,000
